**MINUTES**

Mayor/Chairman Messam called the meeting of the Board of Trustees of the City of Miramar Consolidated Retirement Plan & Trust Fund to order on May 14, 2024 @ 10:12 A.M. in the Commission Chambers on the 1<sup>st</sup> Floor of 2300 Civic Center Place, Miramar, Florida

**TRUSTEES PRESENT:**

**APPROVAL OF MINUTES:**

March 26, 2024– Regular Meeting

Ms. Lodge reported that she emailed copies of the amended minutes to include the change requested/submitted by Vice- Chair Vazquez.

*Trustee Dailey moved to approve the minutes of the March 26, 2024 Regular Meeting as amended. The motion was seconded by Trustee Sanmiguel and the motion passed 9-0.*

**PUBLIC COMMENTS:**

Chair Messam opened the floor for public comments. It was noted there were no members of the public present to address the Board at this time

**INVESTMENT PRESENTATION & CONSULTANT REPORT:**

a. Actuary – Presentation of 10-1-2023 Actuarial Valuation Report- Mr. Jeff Amrose  
Mr. Amrose outlined the items he would be discussing as follows; Required City Contributions for FYE 9/30/2025, how that contribution requirement compared to the contribution requirement from last year valuation report, the Funded Ratio and why it decreased slightly from the prior year.

Mr. Amrose reported that the required Employer Contribution for fiscal year ending 9/30/2025 as stated in the 10/1/2023 valuation is \$12,120,483 or 26.06% of covered payroll, an increase of \$1,946,774 or 0.25% from the 9/30/2023 contribution of \$10,173,709. The contribution has been adjusted for interest on the basis that the contribution is paid in full on the first day of the fiscal year. The actual employer contribution for fiscal year ending September 30, 2023 was \$9,508,735 which was based on the payment schedule.

Mr. Amrose noted that there were no revisions in benefits, no revisions in the actuarial assumptions or methods in this valuation. He reported that during the past year, there was a net actuarial loss of \$11,347,616, which means that the actual experience was less favorable than expected. The loss was primarily due to greater than expected salary increases (12.6% actual versus 5.2% expected for prior

General Plan members and 13.8% actual versus 4.0% for prior Management Plan members) and recognized investment earnings below the assumed rate of 7.0%. The market value return was 7.7%, the return recognized under the asset smoothing method was 5.9% which is less than the assumed return of 7.0%. The net actuarial loss resulted in an increase in the required contribution of 1.70% of covered payroll. The Funded Ratio is 79.4% compared to 81.4% last year.

The actuarial value of assets exceeds the market value of assets by \$9,367,166 as of the valuation date. He commented that the difference will be gradually recognized and, in the absence of offsetting gains, the computed contribution rate will gradually increase by approximately 1.4% of covered payroll. The actuarial value of assets was \$222,932,558 and the market value of assets was \$213,565,392. Net Investment Income totaled \$27,603,129 versus \$8,607,773 in 2020. The Investment Expenses totaled (\$565,067) and the Administrative Expenses were (\$168,671).

Mr. Amrose reported on the GASB 67 noting that with the current 7.0% assumption rate, the total pension liability will be \$56,707,948 using a discount rate of 1% lower (6.00%) the pension liability would be \$88,014,982 and using the discount rate of 1% higher (8.00%) the pension liability would be \$30,118,924. Mr. Amrose reported that the number of active employees as of the 2023 Plan year was 600 versus 553 in 2022. The covered annual payroll for those active employees for the 2023 Plan year after the was \$44,937,113 while the covered payroll for 2022 was \$38,084,738. The number of retirees increased from 346 to 360. Retirees who receive pension benefits from both the General Employees Plan and the former Management Plan are included twice in the count. There are currently no disability retirees, there were 49 terminated vested members. The annual benefits for Retirees, Beneficiaries and DROP members in 2023 was \$12,926,067. The annual benefits for terminated/vested employees was \$847,803. The investment return rate assumed in the valuation is 7.0% per year, compounded annually (net of after investment expenses).

Trustee Taylor referenced page 1 of the report and asked how does the loss recorded there compare to page 35? Mr. Amrose responded it is a full investment loss as reflected on page 13. He commented that page 1, is the total loss and page 5 reflects total investment loss the rest is mainly due to salary increases. Trustee Vazquez posed his question regarding salaries and asked is this something to continue to keep an eye on acknowledging that he understands the City had a lot of pressure to remain competitive in the marketplace when it comes to salary and suggested it may be time to revisit and do an Experience Study. Mr. Amrose referred to page 16 and the two columns which shows, what the actual salary increases for continuing active members and what is assumed.

Chairman Messam asked what has been the experience with other Plans are the losses similar? Mr. Amrose responded that other cities are doing the same thing they are having similar experiences as well. Similar investment losses, maybe on a lesser scale, and similar salary increases. Trustee Vazquez inquired regarding issues with the assumption. It was noted that Tallahassee dictates the assumption and that they might be adjusting the Mortality Table. He reported that FRS (Florida Retirement System) is going to do another Study and there is a good chance there is going to be a higher Mortality Table and the Plan has to use the same.

Trustee Vazquez inquired about the amortization schedule and asked is there pressure to use 20 years versus 30 years' amortization schedule/table/ and if changed how would it affect the Funded Ratio? Mr. Amrose commented he prefers to use 20 years and if changed to 30 for this report it would have no impact because you are changing the liability not the assets. Mr. Amrose reported that the ordinance specifies that the Mortality Table needs to be selected by the Board. As such, he would like the Board if okay, to formally adopt their recommendation of using the Mortality Table that is based on the most recent actuarial valuation report. He commented that it is outlined in the assumption section and that he would like to have that same table they use for funding apply for actuarial

equivalents. Chairman Messam asked is this by motion or resolution? Attorney Levinson stated it can be done separately or as a single motion.

***A motion by Trustee Vazquez to adopt utilization of the latest Mortality Table for Actuarial Equivalent. Trustee Morrell seconded the motion and the motion passed 9-0.***

After the presentation it was noted that there should be a motion to approve the report.

***A motion by Trustee Sanmiguel to accept the 10-1-2023 Actuarial Valuation Report as presented. The motion was seconded by Trustee Vazquez and the motion passed 9-0.***

**Consultant Report – Mariner- Mr. Brad Hess**

Mr. Hess reported that there is requirement that Pension Funds make a declaration of their returns over the short term and the next several years long term thereafter. He reported that their recommendation is to set the rate at 7% which is also what the actuary presented as the return assumption for the pension for the next year and the next several years. The question was asked why 7% assumption? Mr. Hess responded that the aim is to have the return assumption match the return of the Pension Plan over time. He commented that 7.0% is approximately what the average is for most Public Pension Funds. Mr. Amrose commented of the 130 Plans they have the average is 6.95%. Mayor/Chairman Messam commented that this serves as a health card for performance and how much to expect to earn. Mr. Amrose added that the Return Assumption helps balance payments between current and future payments. Attorney Levinson commented that the State wants to know the Board is having a conversation with the actuary. Following discussion;

***Motion by Trustee Vazquez to adopt the 7% Assumption Rate and send the appropriate information to the State. Trustee Taylor seconded the motion and the motion passed 9-0.***

Mr. Brad Hess then presented his Investment Performance Review Report for Period Ending March 31, 2024. He advised the Board that Domestic Equity Markets carried their momentum from late 2023 into the 1<sup>st</sup> quarter of 2024. For the period, the S&P 500 Large Cap benchmark returned 10.6% for the quarter ending September 30. International Stocks were down about 10%; versus 8.6% for the Russell Mic Cap Index and 5.2% for the Russell Small- Cap Index.

Mr. Hess reported that Broad Fixed Income indexes fell slightly during the first quarter of 2024. Market participants were generally optimistic about the possibility of a Fed rate cut during the first half of the year. However, sticky inflation pushed out these expectations and caused the markets to rethink the timing of 2024s potential rate cut. For the quarter, the Bloomberg (BB) US Aggregate Index returned -0.8% while investment grade corporate bonds were down less, returning -0.4%. International Markets showed a healthy rebound in 2023 for the trailing one-year period. For the quarter, the MSCI EAFE Index was the best International performer, returning 15.3% while the MSCI Emerging Markets Index added 8.2%.

Mr. Hess reported on the financial reconciliation noting that the Market Value at January 1, 2023 was \$239,038,917; Contributions totaled \$1,630,556; Distributions totaled -\$3,355,016; Management Fees totaled -\$185,558, Other expenses totaled -\$98,937; Income from investments totaled \$893,576; Appreciation totaled \$11,149,076 and the total Market Value at March 31, 2023 was \$249,072,615.

Mr. Hess reported on the returns noting that the total Fund return for the quarter Net of fees was 5.00% vs. the Policy Index of 4.39%. FYTD (fiscal year to date) 13.67% versus the Index of 13.64%, 10 - year 7.99% compared the index at 8.05% and since inception 7.99% compared to the Index at 8.11%. He stated there are no rebalancing recommendations at this time.

*Trustee Vazquez moved to accept the report as presented. The motion was seconded by Trustee Taylor and the motion passed 9-0.*

The Administrator reported that the items are being presented for ratification noting they have already been paid.

*Trustee Sanmiguel moved to ratify payments of the invoices as listed on Warrant #424 through Warrant #427. The motion was seconded by Trustee Taylor and the motion passed 9-0*

**UNFINISHED BUSINESS**

**Follow up discussion and decision re: Proposal from Auditor regarding Internal Controls Engagement (Presented 11/16/2023)**

Mr. Shawn Davis, Ms. Tanya Davis and Ms. Annette Lewis of S. Davis & Associates attended the meeting remotely to provide an update on the Board's request from the 3/26/2024 meeting. It was noted that the administrator distributed copies of correspondence dated 5/13/2024 received from the auditor outlining the updated scope of service with the fees.

The letter states as a result of the discussion and question/answer session, they, (SDA) added items 1b and 1c to the “Middle” scope from the “High” scope level and the restated fees. Items 1b and 1c scoped items are;

- Sound practices (followed by personnel in performing their duties and functions)
- Systems ensures proper authorization and recordation procedures for financial

Fees for the updated “Middle Scope” is \$39,035.00

Chairman Messam commented that he was not in attendance at the last meeting and as such was/is not privy to the exact concerns that were there. However; he hopes the letter addresses whatever concerns were and that the Board can move forward with the services. He asked is there any discussion on the item? If there isn’t then he would call for a motion.

Trustee Noble commented she has one statement for discussion and noted in the minutes of the last meeting that Mr. Davis expressed that he would be willing to take off \$2,500.00 to make it \$40,000.00 and provide the high scope service. She asked should the Board approves this would they add the notation to the proposed fee they would perform the high scope for the \$40,000.00? Ms. Lewis confirmed that the offer was made however the minutes does not reflect the Trustees response.

Chairman Messam stated he is not sure what the comments were, however his understanding is that what is before Board is what they are proposing based of the discussion at the last meeting. He commented that during the consolidation of the Plans there were some question regarding certain transactions and to ensure that when various member actions takes place or request/change of benefits takes place that the execution of Plan for the respective circumstances that all of the service providers are in sync.

Chairman Messam added that initially there were some cost questions, pricing questions and some scope questions. He asked are these the services the Board wants? He expressed when he was presented even with the higher proposed cost, the attorney said the costs were fair and reasonable compared to other similar services. He commented that unless there’s some material objection in terms of scope that has been brought forward with what the auditor proposed to provide the services his hope is that the Board can move forward.

Discussion took place as to the justification for the cost, Trustee Taylor commented that he has no objection for implementing internal controls and that this has been an ongoing item since November and the Board has not looked at other providers. He asked who does the Board compare the quote to and is the Board 100% comfortable with the price. Chairman Messam stated he was comfortable with the initial price and that the delay is through no fault of S. Davis & Associates but rather because of the Board. He commented that he suggests after this item in future meetings the discuss procurement process on how to evaluate so that there is a process.

Trustee Vazquez offered further perspective of what transpired and the reason to request a tiered scope of service. Trustee Vazquez commented that he was comfortable with mid or low but 1b and 1c which he considers key, were not included. He reported that the Board requested that they restructure and include in all levels and provide a cost.

Chairman Messam commented that the item has gone on long enough stating that the Board should extend some professional courtesy and that it is in the best interest of the members to include internal controls. City Manager Virgin added that he agrees the Board should move forward because of the need noting they had a robust discussion suggesting that they move as is and have a firm discussion if they (the auditors) bring back anything additional. Trustee Vazquez added that he agrees this has been going on since November, they went through and reviewed the low, mid and high scope of service and that he is comfortable with the mid scope and the inclusion of 1b and 1c noting that the price was bumped up from \$36K to \$39K ultimately it was a process to get to where they are now even though

he still does not like the pricing. The Trustees further discussed this item at length, following discussion;

***A Motion by Trustee Vazquez to have S. Davis and Associates perform the Internal Auditing Service at the Middle Tier for \$39,035 and include items 1b and 1c from the High Scope as outlined and attached to the letter dated May 13, 2024. City Manager Virgin seconded the motion and the motion 7-2 with Trustee Taylor and Trustee James voting against.***

**NEW BUSINESS:**

No new business to address.

**ATTORNEY REPORT:**

Update re: Draft Ordinance & Impact Statement

Attorney Levinson reported that he drafted a single ordinance amending certain sections which addresses three changes; *Section 1*-Allows the Plan to create a DROP Loan program, *Section 2* - permits the purchase of Part time service and *Section 3*- Establishes a post retirement option plan for retirees. He briefly reviewed and highlighted some talking points under each section.

**Section 1** DROP Loan Program; A DROP Loan Program is hereby established for retirees who participated in the DROP

Attorney Levinson commented/suggested that MissionSquare would be handling the process and that the Board would have to sign a contract with MissionSquare to do it. He added that MissionSquare will be fiduciary accountable and would stand behind the process as fiduciaries.

**Section 2** Purchases of part-time service- Part time employees who become members shall be permitted to purchase their part-time service;

Allowed to purchase only the equivalent of 75% of full-time service; pay the full actuarial cost; of the part-time service; contribution made by lump-sum or by payroll deductions installments with interest, with the limitation that payments must be completed prior to retirement.

**Section 3** Post Retirement Option Plan;

Allows the member to make a one-time election to set aside a portion of the monthly retirement annuity in the PROP. The election must occur prior to separation from service.

Trustee Vazquez posed several questions regarding the Draft Ordinance's: Section 1 - 5(b) and whether the proposed interest rate on loans could be reduced or eliminated; Section 2 (d) 4 and whether there was parity in such provisions between part-time and full-time members; and, Section 3 – (b) and if there was any flexibility to also allow the election of participating in PROP after separation from service. HR staff agreed to look into the first item concerning the interest rate and confirmed that there was uniformity between part-time and full-time members. Attorney Levinson explained that permitting entry into PROP post separation could present issues and recommended the Board proceed with language as proposed.

A copy of the draft ordinance is included with the minutes.

Attorney Levinson also reminded the Trustees that the Form 1 Statement of Financial Interest must be filed via the Electronic Financial Disclosure Management System (EFDMS) and no longer filed with the Supervisor of Elections office and that the online portal is a direct filing with the Florida Commission on Ethics. He reminded the Trustees that the Form 1 are still due July 1, 2024. Attorney Levinson reported that there is a PowerPoint presentation which the Trustees might find useful in filing/navigating the site and asked the administrator to forward the PowerPoint presentation to the Trustees.
